4. FIRST AID MEASURES

Eye contact - Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. After initial flushing, remove any contact lenses and continue flushing for at least 15 minutes. Keep eye wide open while rinsing. If symptoms persist, call a physician.

Skin contact - Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. If skin irritation persists, call a physician. Immediate medical attention is not required

Inhalation - Move to fresh air. If symptoms persist, call a physician. Immediate medical attention is not required. Move to fresh air in case of accidental inhalation of vapors or decomposition products.

5. FIRE-FIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

Personal precautions - Use personal protective equipment. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak. Pay attention to flashback. Take precautionary measures against static discharges.

Environmental precautions - Prevent entry into waterways, sewers, basements or confined areas. Do not flush into water or sanitary sewer system. Prevent product from entering drains.

Methods for Containment - Prevent further leakage or spillage if safe to do so.
